EPoS Technologies raises CHF 2 million pre-Series A funding in a round led by Nivalis Group.

EPoS Technologies, the Swiss-based startup that has developed electro-sinter-forging, announces today it has raised a CHF 2 million pre-Series A funding round led by Nivalis Group.

Commonly referred to as eForging, the unique technology that EPoS designs, develops and implements allows to create completely new materials, and to produce parts with unprecedented precision, functionalities, density, and strength.

This new investment from Nivalis Group marks the start of a new development phase for EPoS, who will use the funds to strengthen its team, build the first industrial-scale Electro-Sinter-Forging press and start the commercialization of components and materials. The target for the new machine is to achieve a productivity of one part every five seconds and to double the size of the components that can be manufactured. The young company has already attracted interest from a few highly engaged clients who are actively investing in new eforged products.
